#### Terms and Conditions

#### User Agreement

# (1) ACCEPTANCE OF TERMS

# (4) CONFIDENTIAL INFORMATION

User acknowledges that through the Rawhide Distributor Login Program user will gain access to confidential and/or proprietary information of Rawhide that has not otherwise been made publicly known by Rawhide. User acknowledges that this confidential and

proprietary information is and shall remain the property of Rawhide and that making this information available to the User shall not constitute any license or any relinquishment of any trademark, patent, copyright or any other intellectual property rights by Rawhide. User agrees to take the same steps it would take with its own confidential and proprietary information to keep the information made available under the Rawhide Distributor Login Program confidential and not to disclose it to others or use the confidential and/or proprietary information for any purpose other than in furtherance of the business relationship between Rawhide and User. User agrees to take all reasonable steps to prevent unauthorized use of the Rawhide Distributor Login Program.
